



## VSOFF Status Correction Process

**Greetings and salutations to everyone who wishes to be Sovereign, and correct their status on the public record.**

The following will contain the step-by-step process for getting your VSOFF Status Documents completed and filed onto the public record correctly.

The entire set of VSOFF status correction documents is completely filled out by me (Zen) and me alone. No one will ever see the personal information that you send in, (aside from me) and once I am done with creating your VSOFF Status Doc set, I then delete ALL of your personal information OFF of my computer forever.

### To Begin

First, you go to the VSOFF Mega folder to get started. This is where all of the instructions are located (handbills) that explain each and every minor and major part of the VSOFF status correction process.

This folder contains the following:

1. All of the handbills that explain all twelve of the VSOFF Status Documents.
2. The handbill that will teach you how to create your own House seal.
3. How to get two copies of you BCs authenticated on both the State and Federal level, and;
4. How to correctly fill out each of the VSOFF status documents.

Once your payment of 21 rounds of silver, and your check off sheet of personal information from you is properly sent to the VSOFF, as per the VSOFF Price sheet (which is found within the Mega Link), I (Zen) shall diligently create your entire VSOFF Status Doc Set and get it back to you within a week's time. However, the time it will take to complete the entire process will be determined by the speed of which you complete the following list below and how fast the State and Federal governments get your Birth Certificate authentications completed and sent back to you.

I know that some people can become overwhelmed with everything that I have taught over these many years. So, to give you some direction regarding the VSOFF Status doc set process, I would suggest that you watch the all-day status doc class which explains all of the VSOFF Status Documents, why each of them had to be created, how to use each of them correctly, and what each of them contain.

It will take you a little while to watch this set of classes, however it is important for you to do so that you have a good foundation of knowledge of what you are doing. My guess is that many of the other questions you may have will be answered within that set of classes. The step-by-step tasks for accomplishing the VSOF process, is as follows.

1. Get the Great Seal of your House made. (Read the VSOF handbill on how to go about doing this, which is contained within the Mega folder I linked above.)
2. Get two copies of your Birth Certificate from your birth county. You want to have the Birth Certificate, not the Certificate of Live birth. However, if your state ONLY gives out a COLB then that is able to be used for the process, however if able, a simple BC is preferred. Again, the handbills that explain this are within in the Mega folder.
3. Get two copies of your Birth certificate authenticated on both the State and Federal side of government. (The instructions on how to do this are also located within the listed handbills within the Mega file) You will send them to the State first, then you will get them sent back to you with a document riveted into your birth certificate, THEN you will send that document to the feds where they will attach another document to your BC that authenticates it on the Federal side. You will want to get an Authentication NOT an Apostille. However, some states will ONLY give a Apostille, which is fine for those states. It is truly the federal Authentication that matters because of the block of law that is stated upon the federal authentication when you get it back.
4. Send in your 21 rounds of silver as per the instructions within the VSOF price sheet. (The price sheet is also located within the Mega file) You do NOT have to wait for your BCs to come back for me to get started on creating your doc set. In fact, these two tasks should be done at the same time. Just be sure to gather the correct information off of your BC to place into the check off sheet for me BEFORE you send them off for authentication.
5. E-mail to me your check off sheet of information so that I can fill out all of your status docs correctly. (this check off sheet is also located within the Mega file, located within the first folder)
6. Then, I will fill out your VSOF status docs and get them back to you within a week's time.
7. Then you must sign and seal all of your VSOF status docs and have them witnessed by the needed amount of people required for each document. Be sure to refer to each handbill for each document to be sure you fill them out correctly. Again, I am always here if you get stuck or have any questions. They (your witnesses) do NOT have to have done their doc set in order for them to witness yours. If they have no House seal, they can use their right thumb print as their seal. (If you do not know enough people to get this done with you, and or, you are in need of a judicial coroner, you can request to be added to the VSOF signature group on Mega, where we mail to each other the signature pages for the

doc set, sign them for each other, and then mail them off to the next house.) The handbill for the mailing process is located within the VSOF Mega folder at the bottom of the list of items.

8. Once all of your docs are signed and sealed properly, you then will record them onto the public record at a county recorder's office. It does NOT have to be your birth county, nor does it have to be the county you are domiciled within. There is a list of friendly county recorders listed within the VSOF Revolt server if your county is giving you a hard time regarding the filing of your Status Docs.
9. Once your proper documents are recorded you will want to obtain a certified copy of the entire doc set back from them so that you can copy it yourself and save your money from having them print out several copies for you. (The instructions on how to self-authenticate a document is listed within the Mega folder)
10. Then you will process serve the number of agents and government offices you feel are necessary. A list of these offices is in the Mega folder as well. At minimum we suggest: The Federal Secretary of State, the State SOS, the State governor, the DA of your county, the Sheriff of your county, The court administration office of your county, and the President of the United States of America. You can add your county board, your county tax assessor, and anyone else you may be having issues with at the time and wish to place on notice of your change of status in relation to them.

This should be the totality of the process for the VSOF Status Doc set. There are other processes and matters that you should attend to as well regarding the protection of your estate and your removal from the system. These other matters are listed within the VSOF price sheet and stated within the Settlement of your Estate classes.
