

The VSOF has no affiliation with this company, but we can say that they are always reliable and trustworthy. **If you send a payment of silver or gold directly to the VSOF from JM Bullion, or any other metal dealer, BE SURE TO PUT on the address line "Care of VSOF" AS THE NAME ON THE ADDRESS and NOT your name!** If you put YOUR name on the order the VSOF treasurer will NOT be able to sign for it at the post office and the shipment will have to be sent back.

Also, please send the tracking number of the shipment to VSOF@protonmail.com This way your payment will be accounted for and we will know who sent it. Furthermore, the VSOF will take any form of metal, it does NOT have to be in rounds, it can be in bars or other forms, as long as the metal is 99.99% pure and it is the correct amount of ounces for the service.
